#### ANNOUNCEMENTS/COMMUNICATION

### The Mayor:

- Judge Wiggins has opened court on Thursday, May 27th to children seven and older to attend court and sit on the bench with her to observe from the judges point of view
- Earth Day was observed on Saturday, April 22th at the beach with good attendance and great fun.
- Communicated that Caldwell would give a report on Chamblee's street paving project. Caldwell stated that they will pave eight streets at \$325,000 per mile which will be phased over several years and is \$75,000 less that what the County would charge.
- She and Pulsts will meet with Commissioner Steve Bradshaw on May 26th.
- Hammet and Pulsts had a lunch meeting with Senator Steve Henson to discuss annexation. Henson stated that Green Haven dropped on the last day of the assembly and was back in play. He previously stated that he will carve an area for annexation and that it appears that legislation has lost it appetite in the fast-moving of new cities. People need to be educated in annexation and the development of a new city because many do not know the difference.
