**Call to order** at 7:00 by Mayor Melanie Hammet. Present were Mayor Pro-Tem Jean Bordeaux and Council Members Brandy Hall and Megan Pulsts. Council Members Augusta Woods and Kris Casariego were not present. Also present was City Administrator Valerie Caldwell.

#### Announcements/Communication

#### Hammet:

- reported a grant opportunity with Foodwell Alliance which would allow agricultural along the commercial corridor of Rockbridge Road.
- announced that the Resident Open House for the new City Hall at 425 Allgood Road will be on November 3<sup>rd</sup> from 2:00 pm – 4:00 pm and on October 31<sup>st</sup> from 9:00 am – 11:00 am will be the open house for businesses and dignitaries. Approved additional parking will be at the Texaco and Advanced Preparatory Learning Academy.

#### **NEW BUSINESS**

#### **PLAIN** – Grant Application

Tom Ramsey of PLAIN presented a grant application the Association would like to submit to raze the existing gazebo and build a stage in its place. He stated that Council approval was required for the ten thousand dollars grant to be awarded. Discussion included the condition of the existing gazebo. Hammet stated that the gazebo was in bad shape and a hazard and will be

closed immediately with no further rentals. Public Works will be notified on October 15<sup>th</sup> to rope off with caution tape.

Ramsey said that PLAIN will be donating wood for benches that will not be covered in the grant and that SEED will provide landscaping improvements and beautification. A licensed contractor will supervise the construction of the benches. Bordeaux asked if the location of the gazebo could be changed and desired public input. Hammet said that a couple Town Hall meeting will be scheduled for public input and to educate. Ramsey stated the grant application was due the following day. Motion to approve by Hall, seconded by Pulsts. 2-1 with Bordeaux opposing. Following additional discussion, motion to reconsider by Pulsts, Hall seconded and approved 3-0. Motion to move forward with the grant application and solicit public input during the time of submission and award by Hall; seconded by Pulsts, approved 3-0.

## **Dates for Open House**

The Mayor announced that on Thursday, October 31<sup>st</sup> from 9:00 – 11:00 am for businesses and dignitaries and Sunday, from 2:00 – 4:00 pm for residents. Hammet thanked Missye Varner for her efforts for preparation of these two events.

# Agreement between City of Pine Lake and Deborah Bryant for Placement of Art Installation

Hammet presented the draft contract between the City and property owner Deborah Bryant to temporarily install the city's art wall on her property for a nine-month period. Following discussion, motion to approve by Pulsts, seconded by Hall. 3-0.

Hammet stated that Kris Casariego, who is rotating off council at the end of her term this year had been acting as Council liaison and with her departure replacement was necessary.
