CITY OF PINE LAKE CITY COUNCIL MEETING MINUTES SEPTEMBER 24, 2019 7:00 PM

Call to order

The meeting was called to order at 7:00pm by Mayor Melanie Hammet. Present were Mayor Pro-Tem Jean Bordeaux and Council Members Brandy Hall, Augusta Woods Kris Casariego and Megan Pulsts. Also present were Chief of Police Sarai Y'Hudah-Green, City Administrator Valerie Caldwell and City Attorney Laurel Henderson.

Pledge of Allegiance was led by the Mayor.

Announcements/Communication

Hammet:

- announced that ROKS met on September 23rd and have several things going and continue to look at several Rockbridge Road improvements.
- announced that the 2019 art wall photos will be relocated to the 13 acres on Rockbridge Road for a limited time.

Hall:

 communicated that there is a grant offer available for the city and that the chances look good for the city.

Adoption of Agenda

Bordeaux motioned to approve the agenda; seconded by Hall. 5-0

Public Comments

Shirley Kinsey 579 Spruce Drive commented that she is making good progress on the making of the benches for the Club House covered porch. The benches are made from the wood of a one-hundred-year-old-eighty-foot tree that was on her property. Ms. Kinsey also passed out samples of the wood.

Allison Brook 4538 Ridge Drive commented about the gun discharges and fireworks and that it was creating a sense of unsafety. She also stated that safety was a huge concern and is why she moved to Pine Lake.

Sarah Spencer 653 Olive Road commented about the gun fire all the time at Polo Apartment and Haverly Apartments and that she is frightened. She also stated that the gunfire was getting closer and asked what to do to be safe.

Suzanne Hurley 4553 Park Drive commented that she heard gunshots and echoed the other comments. Hurley said that a group of residents met, and that the first thing is to be connected and call 911. She recommended different policing and detailing reports for safety.

Allison Brooks commented that the topic for the neighborhood meeting should be to form an active Neighborhood Watch and for someone to teach how to actively monitor their street so they can jump into action while waiting for the DeKalb Police but to do it safe and smart. She said that her neighbor is beyond scared and that her windows rattle from the shots and fireworks.

Chief Green thanked the residents for speaking up and that the Police Department was doing what they were supposed to do and that the discharge of fire arms and fireworks were a fire hazard and that they have noticed the increase since the legalization of fireworks. The Chief said that she will be meeting with the Neighborhood Watch meeting and encouraged them to attend. Mayor Hammet said that she will attend the meeting.

AGREEMENT

This Agreement is made this	day of	, 2019 between the City of Pine Lake,
Georgia ("City") and Deborah I	Bryant ("Bryant").	

Whereas, Bryant is the owner of a partially developed 13 acre tract of land in the City of Pine Lake located at the intersection of Rockbridge Road and Allgood Road ("the Property"); and

Whereas, the Property contains undeveloped land fronting on Rockbridge Road between an existing business, RCB, and the Pine Lake post office; and

Whereas, the Property is zoned Commercial under the City's zoning ordinance; and

Whereas, the Property is currently listed for sale under its commercial zoning; and

Whereas, the City seeks to improve the appearance of its commercial corridor along Rockbridge Road; and

Whereas, the City desires to demonstrate within its commercial corridor the City's motto, "Art's Natural Habitat" for the purpose of enhancing its commercial corridor and serving as a catalyst to development; and

Whereas, the installation as set out in this Agreement is designed to be visible primarily to vehicles travelling along the Rockbridge Road commercial corridor; and

Whereas, Bryant believes the installation of photographic panels on the Property as set out in this Agreement will enhance the visibility of the Property to potential buyers.

- <u>Section 1</u>. The recitals contained above are incorporated in their entirety into this Agreement.
- Section 2. Bryant hereby grants to the City the right to place an art installation composed of seven panels of photographs illustrating the natural habitat of Pine Lake in accordance with the terms of this Agreement on the Property fronting Rockbridge Road between the business operated by RCB and the post office.
- <u>Section 3</u>. The initial term of this Agreement shall run from the date the Agreement is signed by both Parties for a period of nine months.
- <u>Section 4</u>. The Agreement is subject to one automatic extension for an additional nine month period of time, provided either Party may give to the other Party notice of cancellation prior to the end of the initial nine month term, in which event the extension shall be null and void.

- <u>Section 5</u>. During the term of this Agreement, the City may erect an art installation consisting of seven panels of photographs on vinyl illustrating the natural habitat of the City. The panels shall be installed using existing concrete planters located on the Property and such other support structures and mechanisms as deemed by the City to be necessary to present a professional appearance to ongoing traffic and pedestrians moving along Rockbridge Road.
- <u>Section 6</u>. To the extent GIRMA coverage is available, the City shall indemnify Bryant against loss or damage related to the installation, display or removal of the art installation.
- <u>Section 7</u>. During the existence of the installation on the Property, the City shall be responsible for removal of litter and debris along the frontage of Rockbridge Road in the vicinity of the installation.
- <u>Section 8</u>. Prior to the expiration of this Agreement, the City shall remove the installation and return the Property to its natural state prior to the exhibit having been installed.
- <u>Section 9</u>. In the event of sale of the Property to a third party, the City agrees it shall move or remove the installation as negotiated with the buyer.
- <u>Section 10</u>. The consideration for this Agreement is found in the mutual benefit to the Parties in erection of the installation. No additional monetary exchange shall be made.
