Call to order

Hall communicated that the Post Office will host an event, "How to Grow Your Own Business" on Friday, February 28th at their site.

Hammet reported on the status of community orchard that will be at the Family Dollar location.

Caldwell communicated that the Department of Natural Resources will install video cameras in the eastern or western wetlands to track coyotes. The cameras will be there for two weeks and will be for tracking purposes only.
