CITY OF PINE LAKE COUNCIL ZOOM MEETING JUNE 23, 2020 7:00 PM

CALL TO ORDER

The virtual meeting was called to order at 7:00 PM by Mayor Melanie Hammet. Present were Council Members Augusta Woods, Brandy Hall, Tracey Brantley and Brandy Beavers. Also in attendance were Chief Sarai Y'Hudah-Green and Administrative Assistant Missye Varner. City Administrator Valerie Caldwell was not present.

Announcements/Communication

Tom Ramsey; Resident and VP of PLAIN, announced that on June 18th P.L.A.I.N. meeting Susan Reardon, Lalah Manley, Lee Scott and Holly Mitchell were presented with the Certificate of Excellence of Citizenship. This certificate was awarded for their hard work and keeping the food bank going for the last few months of COVID-19. They were all thanked and received a gift card.

Council Member Woods said that there have been inquires about fishing at the lake and that she has contacted the Department of Natural Recourses Enforcement Division for assistance. She also stated that Kalvin Godby, Stone Mountain Park Ranger, has offered his assistance by providing extra monitoring of the lake. Woods stated that netting is prohibited and will follow up with Chief Green on posting signage of allowed fishing methods and the ordinance stating what can come out of the lake.

Hall communicated that she has received emails from residents regarding pesticides usage within the city.

Adoption of Agenda

Bordeaux motioned to adopt the agenda, seconded by Woods. 5-0

CONSENT AGENDA Meeting minutes of 06/09/2020 Council meeting-Hall motioned to adopt, seconded by Brantley. 4-0 Mayor Pro Tem Jean Bordeaux logged in at 7:09 pm.

OLD BUSINESS COVID-19 Update

Hammet updated that Brantley is assisting with collecting ongoing data for tracking purposes of COVID-19. Brantley shared a power point report that focused on several surrounding counties and their pandemic numbers. She said that cases are still climbing and spreading but in a slow and controlled fashion. The information and graphics were provided by COVID ACT NOW, a non-profit. Brantley said that Gwinnett county is a hot spot and that Pine Lake has had under five cases of the novel virus.

Hammet shared the weekly update from Dr. Kathleen Toomey, Georgia Commissioner of the Dept. of Public Health that this is a novel virus and not a respiratory virus that attacks different systems within the body. Toomey stated that she hopes that Georgia does not inherit new cases from neighboring states experiencing case increases.

The Mayor also talked about contact tracing and the public health management of the beach.

Hammet updated that she has spoken with Council and that beginning in July the city will return to the two monthly meetings. Mayor and Council has been having Zoom Meetings since March 24th.

Public Comments

Resident Stephanie commented that she does not see any reason to change the ordinance for Davis' fence and recommended she obtain a wooden fence because they last longer. She also said that she agreed with council's decision.

Ms. Stephanie shared that she has coronavirus. She stated that she was not able to get food and after posting on a website, citizens delivered her food. Resident Stephanie said that she loves Pine Lake.

Mayor's Comment

There were not any mayoral comments.

Council Comment

Chief Green reminded all that the community is opening up and to be mindful that the pandemic is still active. She instructed residents to grab your mask along with your keys and cell phones. She said after looking at the math, the people must be careful and aware of COVID threat.

Green is reaching out to local agencies regarding their fishing policies and relayed that cast net fishing in the lake is illegal. She stated that the police are doing spot checks and the department is working on a pamphlet to hand out that includes fishing regulations and informs users not to remove the turtles from their habitat.

The Chief commented that she continues to do research on the speeding issue on local streets within the city.

NEW BUSINESS

Wetland and Dam Maintenance

Rich Edinger, CPL Consultants gave a description of the problem and a summary of what would be needed to repair the issue. He presented a geological recommendation proposal and cost to remedy for the entire face of the dam and wetlands. He stated that it could be in phases and would need to bid out the project. Edinger talked about permitting and that he would design a nationwide permit for small encroachments into waters of the United States for maintenance on a dam under specific dam maintenance. Mr. Edinger said that the city needs an updated survey of the area. There was no action taken on this item and it will be placed on an upcoming agenda for further discussion and input before taking the vote.

OLD BUSINESS- COVID-19 Update

Brantley shared the Georgia Situation Report on COVID-19 statistics showing the changes of the virus for one week. The numbers were up 7.2% of cases identified within the state.

Hammet said that the time has changed for the weekly meetings with Dr. Catherine Toomey, Georgia Director of Health and that she missed the meeting. However; Mayor Hammet spoke with Dunwoody Mayor Lyn Dortch and was updated that the hot spots have increased with new COVID-19 cases.

The Mayor said that Governor Brian Kemp has Declared a State of Emergency until August 11, 2020. Hammet communicated that the Census will be getting a portion of the CARES Program funding determined by population. The city has had 52% if its

population counted and thanked Tom Ramsey, Calvin Burgamy and Council Member Brantley for their great work. The mayor will send out a letter via email for all residents to get counted within the census.

Mayor Hammet commented that she will not mandate wearing a mask and that people within the community are practicing social distancing and that there is a lot of masks wearing.

Public Comments

There were not any comments.

Mayor's Comment

Hammet commented that contact tracing is running into blockage with the census and coronavirus and that people need to sign on using their website. Brantley said that 52% of the households has been counted. The Mayor stated that the city is still under counted.

Council Comment

Bordeaux commented that by the Mayor preparing a letter for the census it is a great idea and to add SPLOST information and have a check list.

RESOLUTION NO. R-05-2020

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF PINE LAKE, GEORGIA, TO SET THE MILLAGE RATE FOR FISCAL YEAR 2020

WHEREAS, Title 2, Chapter 5, Section 11 of the Code of Ordinances of the City of Pine Lake, Georgia requires the City to set an ad valorem millage rate for each year for the use in collection of taxes; and

WHEREAS, the City of Pine Lake used the tax digest of DeKalb County to assess taxable property within the jurisdictional limits as provided by law;

WHEREAS, the City of Pine Lake uses the best figures available to determine taxable property.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Pine Lake that a 19.909 millage rate is hereby established for the 2020 fiscal year for the City of Pine Lake.
