Re: Modification of Terms for Beach/Lake Reopening – Hours of Use

New Business Item A. - 05/24/2022 Special Called Meeting of Mayor and Council

In response to public safety concerns submitted to Council by Chief Green on 05/18/2022 and centered around beach/lake closure policies currently set at 9:00pm, Mayor Hammet has issued the call for a special called meeting of Mayor and Council to be held on Tuesday, May 24th, 2022 at 7pm. The purpose of the meeting is to consider beach/lake hours of use policy for approval. The meeting will be held at the courthouse/council chambers located at 459 Pine Drive. Chief Green's concerns were submitted after observing beach/lake conditions at/beyond dark.

Mayor Hammet approved issuance of a special called meeting to consider the matter with the understanding that "We need to get the information prepared in advance of our June 2 opening with enough lead time for signage and public notification" – in the instance that Council approves the modification of hours.

The following are points to consider as Council prepares for the 05/24/2022 meeting discussion and policy decision:

Chief Green's request (as a bare minimum) is to consider a reconsideration of policy moving from beach/lake opening at 6am and closure at 9pm to beach/lake opening at dawn and closing at dusk. Please see Chief Green's initial email request highlighted below.

#### Public Safety Concerns:

- Sunset hours before the 9pm closing time enacted by recent policy.
- Inability to identify bodies in and to safely supervise the exit of bodies out of the water at dark/beyond dark.

#### **Operational Concerns:**

Shift coverage change is scheduled for 10pm each evening. With a 9pm\* closing, officers have the task of clearing the water, clearing the beach, ensuring the safety of clearing, and completing other service duties as follows by 10pm:

- complete report submissions
- gas up public safety units
- complete final tours of the city
- stand by as our business owners walk safely to their vehicles

\*When dusk happens after 9pm, the window for the completion of duties is tightened all the more.
