A RESOLUTION RECOGNIZING AND DIRECTING PUBLICATION OF 2025 GENERAL MUNICIPAL ELECTION RESULTS ON THE MINUTES OF THE CITY OF PINE LAKE

WHEREAS,	On November 4, 2025, in accordance with the City's Charter and the General Laws
	of the State of Georgia, the City of Pine Lake held its biannual election to fill 3 at-
	large seats on the City Council; and

- WHEREAS, Three candidates qualified and were listed on the ballot to fill the three open seats; and
- WHEREAS, Pursuant to the City's Charter, Councilmembers are elected at-large, meaning there are not separate districts within the City of Pine Lake from which each represented must be selected and must reside; and

WHEREAS, The results of the election as reported by the Georgia Secretary of State show

WHEREAS, The City Charter provides that winners are designated as the three highest vote receivers in the General Election;

NOW THEREFORE, BE IT RESOLVED by the governing authority of the City of Pine Lake, Georgia, that the City recognizes the winners of the Municipal Election for the City of Pine Lake as described and enunciated above and that the City will hold a swearing-in and organizational meeting of the new Council in January 2026 as prescribed by the Charter.

TITLE: Dam Improvements Project

RECOMMENDATION

Approve the bids for improvements to the Pine Lake Dam based on the September 2025 Dam Inspection Report submitted by the City's engineering consultant, AECOM including the quote from Avalon Tree Services for \$21,000, which covers debris removal from Upper Snapfinger Creek and vegetation removal from the upstream dam area (\$8,000), and vegetation and tree removal from the downstream dam area (\$13,000); the quote from D&L Contractors for \$60,000 to handle grading, hauling, and stabilizing the upstream dam area; and the quote from Deerfield Paving for \$21,500 to supply and deliver stabilization materials for use on the upstream dam area.

BACKGROUND

AECOM initiated an inspection of the Pine Lake Dam on August 19, 2025. The Dam Inspection Report was presented to The Mayor and Council at the October 14, 2025 Work Session. The report includes recommendations that staff plan to implement to make the structure compliant and suitable for its intended purpose. Recommendations include removing debris in the upper reach of Snapfinger Creek, removing vegetation and stabilizing the upstream shoreline of Pine Lake, as well as managing vegetation of the downstream slope of the Pine Lake Dam.

RESOURCE IMPACT

Funding for this project is from the Small Cities Intergovernmental Agreement Capital Fund.

A RESOLUTION AUTHORIZING CONTRACTS WITH DESIGNATED VENDORS TO CONDUCT REMEDIATION TO LAKE AND WATERWAY STRUCTURES, TO AUTHORIZE THE MAYOR TO EXECUTE ANY AND ALL NECESSARY DOCUMENTS, AND FOR OTHER PURPOSES

- WHEREAS, The City owns the land and waterways on either side of Snapfinger Creek, and around the artificial body of water known as Pine Lake; and
- WHEREAS, The Charter of the City of Pine Lake authorizes the ownership and maintenance of real and personal property for the public's use at sections 1.12(18) and (19); and
- WHEREAS, The City Council has been provided with a report on, and asked questions about the current state of the waterways and lake front; and
- WHEREAS, In addition to its current use for storm water management, aesthetic and recreational purposes, the waterways are an important natural resource of the City and require routine maintenance to remain usable and functional; and
- WHEREAS, the Vendors selected all responded to parts or all of a Request for Proposals made by the City to the Community seeking qualified and responsive contractors to perform this essential and long-delayed work.

NOW THEREFORE, BE IT RESOLVED by the governing authority of the City of Pine Lake, Georgia, that the following vendors are approved at the specific amounts shown for their portion of the project:

BE IT FURTHER RESOLVED that the City Manager, in consultation with the City Attorney, is directed to cause appropriate contracts to be drawn and prepared for execution by the vendors above and the City to have the work anticipated by this Resolution promptly and professionally performed.

BE IT FURTHER RESOLVED that the total project cost approved by the Governing Authority is not to exceed \$102,500.00 and the City Manager is expressly authorized to utilize savings by one vendor to address necessary change orders or additional costs encountered up to the limit of the allocated funds; provided however, that Council must still approve any such change orders to increase the amounts identified by each Vendor in the response to the City's Request for Proposals. Any unused funds are to be transferred by the City Manager back to the applicable City Fund for further or different allocation as the Council may elect.

BE IT FURTHER RESOLVED that the Mayor is expressly authorized to execute any and all necessary documents to give effect and purpose to this Resolution without further action by the City Council. The Acting City Clerk, in consultation with the City Attorney, is authorized to correct any scrivener's errors or other technical issues with this Resolution.
